4. That the objects of the trust shall be achieved without involving any profit motive as described in the Income Tax Act, 1961.
5. That in order to carry out the objects of the trust, the trustees may in their discretion, manage, supervise or look after any other trust, trust property having similar aims and objects existing solely for the purpose of educational institutions viz. colleges, school, libraries, vocational and training institutes etc. affiliated or unaffiliated at Rewari elsewhere in India.
6. That on execution of this trust deed, the trustees shall take charge of the said property i.e. Rs. 21000/- (Rupees Twenty One Thousand Only) and it shall be the corpus of fixed property of the trust and it shall not be disposed off or subjected to any change, for the purpose of meeting the expenses or for carrying out the objects of the trust or for any other purpose unless otherwise resolved unanimously by the trustees.

and such other properties (both moveable and immovable) as may be acquired from time to time by the trust by purchase, exchange, grant subscription, lease, endowment, donation, contribution or in any manner whatsoever (all of which be designated as '**TRUST PROPERTIES**' of the trust here-in-after mentioned).

8. The trustees shall have the power from time to time to increase the corpus of fixed property and funds of the trust and this corpus will not be used in contravention of the aims and objects of the trust.
9. The trustees shall have the powers to frame rule, regulations and bye-laws and to form committees to carry out the objects of the trust.
10. The trustees shall have the powers in general to acquire all things and to do all acts necessary to carry out the objects of the trust.
11. The trustees shall not be entitled to any remuneration and shall work in honorary capacity. They shall however be entitled to receive out of pocket expenses incurred by them in the course of discharging the duties as trustees.
12. The trust shall be governed by the board of trustees. The board of the trustees shall consist of all the trustees whose number shall solely depend upon the discretion of the President.
13. (a) The first President of the trust shall be Rajul Bountra for life time and he shall have the right to nominate the next President, in case of failure to nominate the successor President, the trustees shall be entitled to choose the President amongst themselves.

in his discretion. Such nominated trustees shall have the powers similar to the other trustees including the right voting.

(c) The President shall have the power to terminate or suspend any trustee.

14 The trustees shall have no power to amend, alter, substitute or rescind clause 1,3,13,25,26 and other clause regarding the powers of the President.

15 That the trust may open account in any bank or banks which shall be operated by the President and Secretary. For operation of various funds of the institutions run by the Trust e.g. **Salary, Fixed Account, Sports Fund** etc. The Trustees may authorize the Head of the Institution and some trustees to jointly operate them.

16. That for the purpose of carrying out the objects of the trust, the trustees shall have power to acquire by purchase or lease otherwise any immoveable property and in case of land the trustees shall be at liberty to erect building thereon and to do all acts necessary and incidental thereto.

17. It shall be lawful for the trustees to pull down, renovate, rebuild, alter, adopt improve, add to develop or repair any immoveable property comprised in the trust properties and spent thereon such money out of the trust fund or the income thereof as they may deem fit.

18. It shall be lawful and competent for the President in his discretion to make donations from the trust properties and to spend the money of trust in his discretion to make donations in any other manner to carry out the objects of the trust.

19. That the entire control, regulation, management, application and administration of the trust properties income, rent interest or profits of any kind shall be in the discretion of the trustees.
20. That the board of trustees shall meet at least once in a year but number of other meetings may be held as and when considered necessary.
21. That in case the trustees are divided equally in opinion, the matter shall be decided according to the casting vote of President in addition to his own vote as a Trustee.
22. Qualification of Trustee:
- (a) No person can be trustee unless he or she:-
- (i) is a Indian nationality
- (ii) believes in the aims and objects of the trust and is adult.

24. The President shall be responsible to see the management of the trust and shall see that the office bearers discharge their duties properly. In case of gross negligence, the President may relieve or suspend such officer bearers; dissolve committee if any constituted by the Board of Trustees and may carry out the management of the trust himself.
25. That the trustees shall have no power to remove the President or



**THIS DEED OF AMENDMENT IN THE TRUST** is made and executed on this the 14<sup>th</sup> day of September, 2017 by Mr. Rajul Bountra S/o Late Sh. Amarnath Bountra aged about 70 years, resident of H.No.473-P, Sector-3, Part-1, Rewari-123401, Haryana party of the First Part (hereinafter referred to as the SETTLOR AND PRESIDENT OF THE TRUST namely "BOUNTRA ACADEMY" which expression shall, unless repugnant to the context include his heirs, executors administrators, representatives and assigns) on the one part

**AND**

Mr. Rajul Bountra S/o Late Sh. Amarnath Bountra aged about 70 years, resident of H.No.473-P, Sector-3, Part-1, Rewari-123401, and Haryana (hereinafter referred to as the PRESIDENT AND TRUSTEE NO.1)

**AND**

Mrs. Reena Bountra w/o Sh. Rajul Bountra aged about 70 years, resident of H.No.473-P, Sector-3, Part-1, Rewari-123401, and Haryana, (hereinafter referred to as the TRUSTEE NO.2)

**AND**

Mr. Rupesh Bountra S/o Sh. Rajul Bountra aged about 35 years, resident of H.No.473-P, Sector-3, Part-1, Rewari-123401, and Haryana, (hereinafter referred to as the TRUSTEE NO.3)

**WHEREAS THE SETTLOR AND PRESIDENT** is desirous of amending/substituting/adding the existing clause no. 1, 2, 12, 13, 14, 18, 23, 24 and 25 of the Trust and the Trustees have also agreed to the intention in view of the powers conferred under clause no.9 of the trust deed dated 02-01-2009 and registered on 13-02-2009 vide deed no. 7109.

**AND WHEREAS** in order to give it a formal and legal shape to intention of the Settlor, President and trustees, it has been decided to make an amendment in the Trust Deed in writing to cover the intention as aforesaid ;

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-**

**1. The clause no.1 shall be as under:-**

*That the name of the Trust shall be "**BOUNTRA ACADEMY**". The trust shall be irrevocable charitable trust.*

**2. The clause no.2 shall be as under:-**

*That the registered office of the trust shall be situated at NS-6, Sector-4, Rewari-123401, Haryana.*

**3. The clause no.12 shall be as under:-**

*That the trust shall be governed by the board of trustees. The board of trustees shall consist of all the trustees. The total number of Trustees shall neither be less than four nor more than seven, including the first Trustees. The new trustees can be appointed by majority of votes by the board of trustees.*

5. The clause no.14 shall be as under:-

That the board of trustees shall have the power to accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, society, govt. agency, central or state govt. local authority, with or without conditions for the trust.

6. The clause no.18 shall be as under:-

That it shall be lawful and competent for the board of trustees to make donations from the trust properties and to spend the money of trust, to make donations in any other manner to carry out the objects of the trust.

7. The clause no. 23 shall be as under:-

That the trustees and office bearer of the trust are as specified above in clause 12 at Sl. No.3
